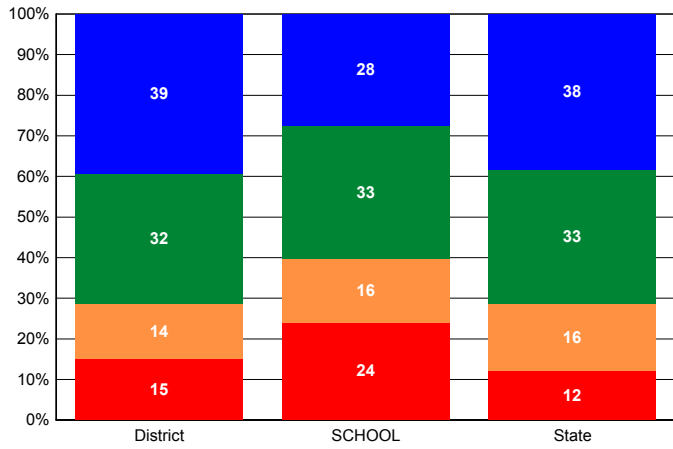

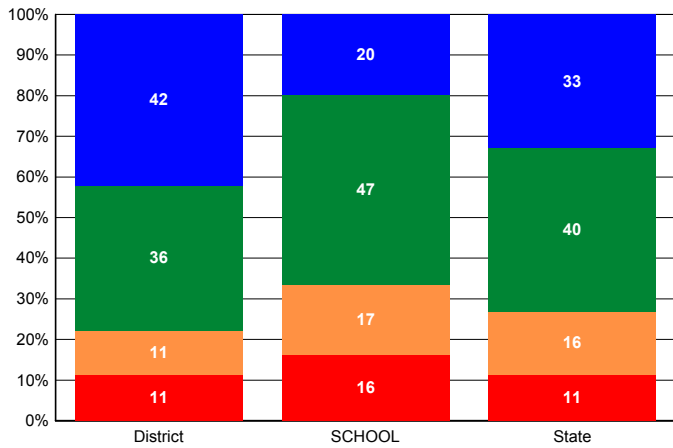
Reading - Grade 4



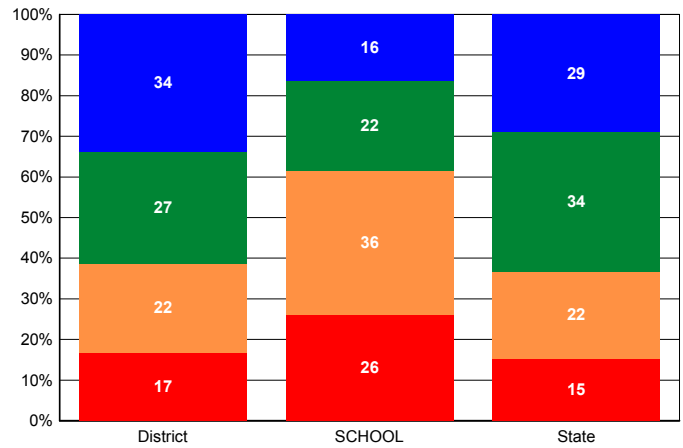
Math - Grade 4



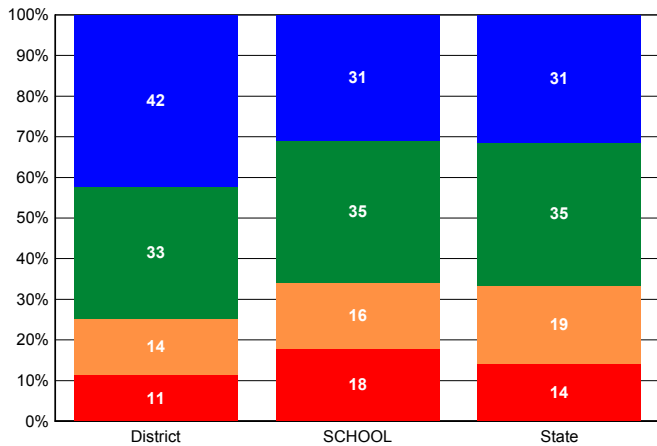
Reading - Grade 5



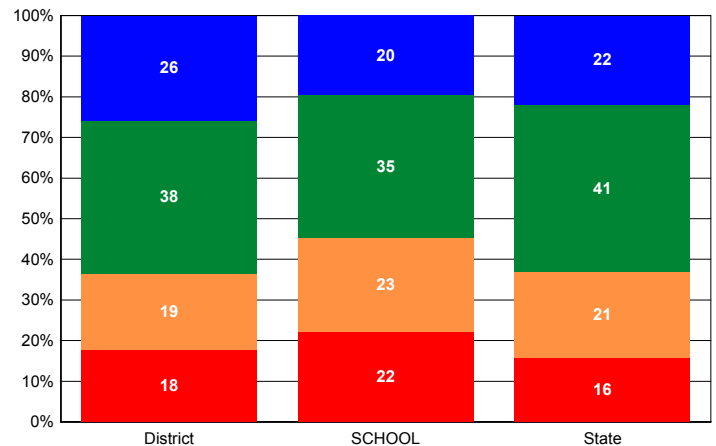
Math - Grade 5
